From Quakertown Office - From office complex, turn LEFT onto Route 309 South. Turn LEFT onto Route 313. Go through Quakertown and over Railroad tracks. First Light after RR tracks, turn LEFT onto Route 212 East. Turn RIGHT onto Meadow Drive, then Right onto Aubrey Drive. House is on right. Rancher.
