BARC Developmental Services is proud to present the 4th Annual Fall Classic Car Show and Vendor Market at its new location, the Sellersville Fire Department located at 2 N. Main Street, Sellersville, PA 18960. BARC Developmental Services is a nonprofit human services agency serving Bucks County since 1951. BARC provides support for men, women and children with intellectual disabilities and autism. We welcome local businesses to participate in our Vendor Market. Space is limited and applications will be reviewed in a timely manner by a representative of the Event Committee. Vendors will receive a confirmation email once approved. The entry fee, which entitles the applicant to an 8-foot space indoors with access to electric and Wi-Fi, is \$40. Checks should be made payable to BARC Developmental Services. Only one vendor is permitted per space.

All vendors must provide a copy of their liability insurance before their application can be confirmed. If the application deadline passes and full payment along with proof of insurance has not been received by September 20th, you will forfeit your space. If payment has been received, but no proof of insurance, you may receive a refund for half of the total paid, if you complete a request in writing to BARC Developmental Services, PO Box 470, Holicong, PA 18952. If we do not receive a written refund request, the payment will be considered a general donation to BARC Developmental Services.

Spaces are located within the Banquet Hall of the Sellersville Fire Department. Your space will be assigned to you day of at check in. Vendors may begin to set up at 9AM. Vendors may unload, and all cars must be moved to designated parking no later than 10:30AM. Absolutely NO parking in NO PARKING ZONES. Access must remain for firefighters. Sponsors may have an indoor and outdoor space. Outdoor space will be 10 x 10 and if you bring a tent, it must be weighted. An event committee member will be inspecting spaces. All vendors are asked to stay for the duration of the event. You will not be able to pull your car back up to the building until after the event commences.

The 2025 Fall Classic Car Show & Vendor Market is brought to you by BARC Developmental Services Inc., a 503(c)(3) non-profit whose mission is to serve and advocate for individuals with intellectual disabilities and autism. Your participation in this event helps to support our programming.

- 5. It is the sole responsibility of each accepted vendor to obtain any and all required, applicable and appropriate state and local licenses/permits needed. Each vendor also bears the sole responsibility for payment of all taxes pertaining to their operation.
- 6.
