

SUMMARY ANNUAL REPORT FOR BARC DEVELOPMENTAL SERVICES MONEY PURCHASE PENSION PLAN (MPPP)

This is a summary of the Form 5500 Annual Return/Report of Employee Benefit Plan for the BARC Developmental Services Money Purchase Pension Plan (MPPP), EIN 23-1489800, Plan 001, for period July 1, 2024 through June 30, 2025. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, money purchase, ERISA section 404(c), total participant-directed account, pre-approved, single employer type of plan.

Basic Financial Statement

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$260,890. These expenses included \$24,779 in administrative expenses and \$236,111 in benefits paid to participants and beneficiaries. A total of 142 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$4,372,005 as of June 30, 2025, compared to \$4,214,570 as of July 1, 2024. During the plan year, the plan experienced an increase in its net assets of \$157,435. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$418,325, including earnings from investments of \$418,325.
