

SUMMARY ANNUAL REPORT FOR BARC DEVELOPMENTAL SERVICES THRIFT PLAN

This is a summary of the Form 5500 Annual Return/Report of Employee Benefit Plan for the BARC Developmental Services Thrift Plan, EIN 23-1489800, Plan 002, for period July 1, 2024 through June 30, 2025. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, ERISA section 404(c), total participant-directed account, Code section 501(c)(3) annuity contract, single employer type of plan.

Basic Financial Statement

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$1,329,917. These expenses included \$94,813 in administrative expenses and \$1,235,104 in benefits paid to participants and beneficiaries. A total of 326 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$13,025,197 as of June 30, 2025, compared to \$11,904,014 as of July 1, 2024. During the plan year, the plan experienced an increase in its net assets of \$1,121,183. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$2,451,100, including employer contributions of \$217,798, employee contributions of \$691,792, other contributions of \$107,580 and earnings from investments of \$1,433,930.
